## **RE: Riverwatch Condominium House Rules**

Riverwatch condominiums shall be used for residential purposes only. Owners/tenants/guests shall not use condos in any way that interferes with the use and enjoyment of premises belonging to neighboring condo residents. No commercial, illegal or improper activities are allowed. Residents shall comply with all Zoning Ordinances, Protective Covenants, Deed Restrictions, Declarations and House Rules.

- 1. All owners must complete the Owner Information Form and give to Association Management before being issued a gate card and parking permission. (Management hours are Mon-Fri, 9:00AM 5:00PM, unless <u>prior</u> arrangements are made.) There is no extended or overnight parking allowed in the loading/unloading zone.
- 2. Only <u>one</u> vehicle per A or B unit is allowed for garage parking. <u>NO MOTORCYCLES</u> <u>ALLOWED IN THE GARAGE</u>. Contractors, maid service, air conditioner repair service, plumber service etc should use the OUTSIDE PARKING AREA and not park in the garage.
- 3. All children under 16 years of age must be constantly monitored while in the confines of the building. Please instruct them in proper use of the elevator as it could be a danger to small children.
- 4. All bicycles shall be parked in the bike rack in the garage.
- 5. No dogs are allowed within the confines of the building (service dogs with approval only). Feeding of wild or stray animals is prohibited.
- 6. Luggage carts are not to be stored inside a condo. Please return luggage cart promptly after use and return to the luggage cart storage area.
- 7. Swimming pool regulations are posted at the pool on the 4<sup>th</sup> floor. Period of use is DAWN to DUSK. Children under 16 years of age must be supervised by an adult <u>at all times</u>. Do not keep the door that allows access to the pool "propped open".
- 8. Tenants should contact their <u>rental agency or landlord</u> if you have any problems or have locked themselves out of their unit.
- 9. Any Riverwatch owner and/or resident desiring to have a group (more than 4 per unit) use the Riverwatch pool or pool area, must have the event (date, time, and number of guests) approved by the Riverwatch Board of Directors at least 8 days prior to the event. Memorial Day, July 4<sup>th</sup>,

and Labor Day are not available for group events; these days are reserved for activities sponsored by Riverwatch Condominium Owners Association owners.

- 10. Continued disregard for house rules will result as a consequence to the owner:
  - A.  $1^{st}$  offense a letter will be sent to the owner describing the
  - B.  $2^{nd}$  offense a letter with an invoice will sent to the owner in the amount of \$100.00
  - C.  $3^{rd}$  offense a letter with an invoice will be sent to the owner in the amount of \$250.00
